

THE PRESENTATION

In this presentation, Dr. Jacobs will focus first on the current controversies concerning the role of memory in the psychoanalytic process and second on the role the analyst's inner experiences play in enlarging, enriching, and deepening the listening process and the entire analytic experience.

Regarding memory, there has been a trend recently to emphasize the importance of implicit or procedural memory and to regard explicit or declarative memory to be of little importance in fostering change. Dr. Jacobs takes issue with this view and by means of clinical and literary examples seeks to demonstrate the central role played by declarative memory in the analytic process and the process of change.

Turning to the role of the analyst's inner experiences, Dr. Jacobs uses specific clinical examples to illustrate how the analyst uses his inner experiences in the clinical work. Additionally, the presenter takes up the difficult question of sharing some of the analyst's subjective experiences with patients and argues that in selective circumstances such sharing helps anxious and distrustful patients to reveal themselves and to participate more fully in the analytic process.

- 1. Discuss the differences between declarative or explicit memories and procedural or implicit memories.
- 2. Describe how the analyst's inner experiences can be used to enhance the interpretive process.
- 3. Discuss the pros and cons of the analyst sharing some of his/her experiences with patients.

THE PRESENTER



Theodore Jacobs, MD, is a graduate of Yale University and the University of Chicago School of Medicine. He did his psychiatric residency at the Albert Einstein College of Medicine where he is currently

Clinical Professor of Psychiatry (Emeritus). His psychoanalytic training in both adult and child analysis was at the New York Psychoanalytic Institute. Currently he is a training and supervising analyst at both New York Psychoanalytic Institute and the Institute for Psychoanalytic Education.

He is the author of two books: "The Use of the Self: Countertransference and Communication in the Analytic Situation" and "The Possible Profession: The Analytic Process of Change" and has co-edited a third, "On Becoming an Analyst" with Arnold Rothstein.

Dr. Jacobs serves on the Editorial Board of three analytic journals and is also the author of sixty-five articles on a variety of analytic topics, plus many book reviews. Recently he published "*The Year of Durocher*", a coming of age novel.
